# Service Spotlight: Domestic Violence Services

Domestic Violence, 37.7% of women and 25.7% of men in Illinois experience intimate partner physical violence, intimate partner sexual violence and/or intimate advocates responded to 83 hospitals calls. partner stalking in their lifetimes.

Mutual Ground is a safe place where people come together to break the cycle of domestic violence. Mutual Ground provides a wide range of domestic violence services to residential and non-residential clients, including: Counseling (Individual, Group, Family and Hotline); Case Management, Housing Advocacy, Educational Advocacy, Employment Advocacy, Linkage to Economic Supports; Legal Advocacy, Civil & Criminal, and Medical Advocacy.

According to the National Coalition Against Last year, Our Domestic Violence Program served 903 adults and 314 children. We provided emergency shelter to 363 residents for a total of **8,654** nights of stay and victim

children and families, and enhancing training and outreach that has resulted in the provision of shelter services to more trans, gender non-conforming and maleidentified victims.

Two pillars in the community are joining forces to enhance the services offered by their agencies. Mutual Ground and Breaking Free have signed paperwork to combine their entities and are planning a full merger by July of 2020.

Both Mutual Ground and Breaking Free have served the community for more than 40 years. Mutual Ground, founded in 1975, provides education, awareness and lifechanging services that empower individuals, families and communities to end the cycles of domestic and sexual violence. Breaking Free, founded in 1977, helps build strong family foundations and rebuild those impacted by substance abuse, child abuse and other life challenges. Together they will be able to provide exceptional service to members of the community who are experiencing a wide range of issues that sometimes overlap.

According to the American Society of Addiction Medicine nearly 40-60% of

domestic violence crimes are related to the use of alcohol/and or drugs. And a study by the Illinois Department of Housing Services found that of women in a drug treatment center, 90% had been physically assaulted and 95% had been raped. In addition, substance abuse is often used as a coping mechanism to help deal with the trauma endured by sexual and domestic violence victims.

According to Michelle Meyer, Executive Director of Mutual Ground, "By joining forces with Breaking Free, Mutual Ground will be better able to meet the increasingly complex needs of today's individuals and families. Both agencies provide a vital service to the community and help thousands of individuals annually. This merger just increases our ability to help people heal when they are facing overwhelming challenges in their lives."

Both agencies collaborate with schools, law enforcement agencies, local coalitions and other human service organizations to help strengthen communities in their service area. This unique approach offers prevention services, intervention services, and ongoing support for victims of domestic and/or sexual violence, and those facing substance abuse issues.

According to Teddi Krochman, retiring Executive Director of Breaking Free, "Both Breaking Free and Mutual Ground use nationally recognized prevention and educational programs to build the life skills people need to thrive and make positive decisions for themselves and their families. Every client comes to us with unique challenges. This merger allows us to meet those challenges in a direct way, and helps clients rebuild their lives with services that are tailored to the individuals needs to best ensure success."

# **Types of Abuse**

Abuse comes in many forms. Domestic violence is a pattern of behaviors used by one partner to maintain power and control over another partner in a relationship. While physical violence may be the first thing that comes to mind when one pictures domestic violence, abusers exert their control in many other ways.

Here are just a few examples of how an abuser exerts power and control over a partner:

### **Physical Abuse**

- Scratching, punching, slapping, biting, or kicking
- Throwing something at partner
- Hair pulling and grabbing clothes
- Restraining and preventing partner from leaving
- Grabbing partner's face to make you look at them
- Using a gun, knife, mace or other weapon

## Verbal Abuse

- Name calling, belittling, and making demeaning comments
- Yelling and threatening harm
- Intentionally embarrassing partner
- Undermining their partner's authority with children
- Manipulation
- Blaming partner for their actions

### **Controlling Behavior**

- Telling partner what to wear and who they can talk to
- Accusing other people of flirting with partner
- Monitoring phone and online communication
- Extreme jealousy and obsessiveness

### Sexual Abuse

- Pressuring, threatening or forcing partner to have sex or perform sexual acts
- Making degrading sexual comments
- Restricting access to contraception and birth control
- Unwanted kissing, touching or other sexual activity

### **Emotional Abuse**

- Controlling activities
- Gaslighting partner
- Threats of violence against others or themselves
- Preventing partner from seeing or talking with family and friends
- Threatening to tell others about private things such as sexuality or immigration status

### **Financial Abuse**

- Keeping partner from seeing shared bank accounts or records
- Taking or deny money
- Restricting access to household finances
- Not allowing partner to work or attend school
